3- Single stage-two envelope procedure: The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal. The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion.

4- The Technical Proposals and Financial Proposals will be submitted according to the give pattern as specified in the documents of Terms and Conditions.

5- Quotations for different products will be mentioned on separate pages. The name of the quoted product should be displayed clearly on the page.


6- Only those firms who qualify technical evaluation will be allowed to be considered in financial evaluation.

7- Delivery will be made within 30 working days after issuance of purchase order.

8- All bidders must submit pay order @5% of the total bid value as earnest money in favour of Interior Division. The earnest money of successful bidder will be returned after expiry of warranty period.

9- Deadline for the submission of the bids is 8th May, 2017 and those should reach before 01:00 p.m. on the given date. Tenders/bids will be opened on the same day at or after 2:00 p.m. in the presence of bidders / representatives.
