Security deposit will be released/refunded whitin a fortnight to unsuccessful bidders and in case of successful bidders after 8<sup>th</sup> November,2018.
- The rates quoted will remain valid up to 30<sup>th</sup> June, 2019. Sub-standard work, etc will not be acceptable and defaulters will be proceeded under law, including blacklisting.
- Firms will be bound to depute full time representative to carry out the repair/maintenance round the clock even on short notices and no closed holidays on the approved rates throughout the financial year at their own transport in "R" block Pak-Secretariat, Islamabad.
