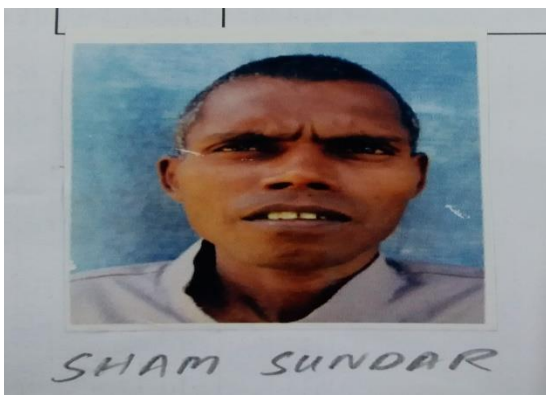


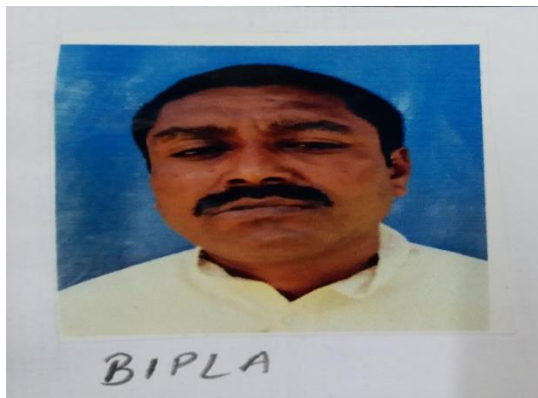


IDENTIFICATION REQUIRED
