Subject: **FINAL EVALUATION REPORT FOR HIRING OF TESTING AGENCY FOR RECUIRTMENT TO VACANT POSTS IN (BS 01 TO 15) IN MINISTRY OF INTERIOR.**

Ministry of Interior invited tender from reputed testing agencies through an advertisement in the National dailies on 13.01.2022 to carry out recruitment against the various vacant posts. In response to the tender invitation, three (03) testing agencies submitted their bidding proposals. These included National Testing Service (NTS), Fair Testing Agency (FTS) and Allied Testing Services. Technical bids were opened on 31<sup>st</sup> January, 2022 at 1300 hours. The bids were evaluated strictly in light of PPRA Rules/ Criteria. The final results of evaluation are as under:-

**Technical Evaluation:**

M/s NTS secured 83 out of 100. The 70% weightage for technical qualification as per section-7 of the bidding documents of single responsive bidder i.e. NTS is **58.1**

**Financial Evaluation:**


Testing Agency has quoted lump sum processing fee per application (all inclusive) equal to Rs. 350/- (All type of test of all eligible candidates inclusive government taxes). The 30% weightage of the qualified bidder comes to 30.

2. The technical proposals were examined by the Committee and finalized on 15.02.2022. The proposals submitted by ATS & FTS were rejected by the Committee as these Testing Agencies were not fulfilling the clause 6(b) of the eligibility criteria of bidding documents & terms of reference (TORs) for hiring services of testing agency. M/s FTS launched a grievance on 28.02.2022. The Grievances Redressal Committee met on 7<sup>th</sup> March 2022 and heard the grievances of FTS in person. The Committee, after detailed deliberation, decided to reject the grievances of FTS.


3. Accordingly, in light of above, the Committee unanimously noted that the rates quoted by the NTS are reasonable and in conformity with the prevailing market rates. Therefore, the Committee has recommend that the contract for recruitment process against the vacant posts in Ministry of Interior may be awarded to National Testing Services (NTS) at quote rate of Rs. 350/- per eligible candidate. The Committee also recommended that contract terms and conditions may be negotiated and finalized with M/s NTS at the earliest.
